# Canada's National Port System

- 19 Canada Port Authorities:
  - 250 M Tonnes of Cargo
  - Valued at Over \$100 Billion Annually
  - 250,000 Direct and Indirect jobs
  - Three Container Ports
- Several Hundred Regional Public and Private Ports Handle Another 200 M Tonnes

#### CTA Amendments

"5 (b) ...regulation and strategic public intervention occur only if they are necessary to achieve economic, environmental or social outcomes that cannot be achieved satisfactorily by competition and market forces and they do not unduly favour, or reduce the inherent advantages of, any particular mode of transportation."



## Key Elements for Ports

- Report on State of Transportation in Canada
  Before Parliament Every 3 Years
- 8-year Review of the CTA or Other Transportation Related Acts (CMA?)
- Review of Mergers and Acquisitions Re: Matters of 'Public Interest'
- Minister May Refer Matter to the Canadian Transportation Agency (150 days)



## Canada Marine Act

- Mandatory 5-Year Review Completed June 2003
- 22 Positive Recommendations by Review Panel
- Bill C-61 Tabled in Spring of 2005
- Bill C-61 Died Merciful Death in November 2005
- Awaiting New, Improved CMA



#### A New CMA

- 1. Local Taxes to be Paid by Land Owner Not Manager
- 2. Direct Access to Federal Funding by CPAs
- 3. Eliminate Borrowing Restrictions on CPAs
- 4. Eliminate Gross Revenue Charge on CPAs
- 5. CPAs to Retain Proceeds from Land Sales



#### CEAA

- Mandatory 5-Year Review Completed
- Federal Lands Puts Ports Under CEAA
- Ports Provided Direct Input
- Ports Concerned with Coordination and Timing
- CEAA Now Being Reviewed
- Ports Made Case for Expanded Exclusion List
- Ports Made Case for Better Coordination and Timing - AGAIN!
